Our Control Guarantee:

In most cases, we provide a control guarantee of a 75% to 95% reduction of insect pests. This is based on four factors:

1. Soundness: Gaps in doors, windows; roll-up garage doors; and utility entries for pipes, electrical, etc. provide convenient points of access for pests.

2. Type of landscaping: Having bark, grass, or dirt at the base of a structure can greatly decrease the percentage of control because these mediums absorb the product we lay down. Our products are most effective when the structure is surrounded by small-diameter rock, asphalt, or concrete because the product remains on the surface of these mediums.

3. Frequency: The number of treatments performed on your home each year directly affects the efficiency of the product. We recommend your home be treated at least 3-4 times each year; for some properties, we suggest treatment on a monthly basis.

4. Clutter: How many items are in and around the structure, basically how much we are able to treat due to the amount of things that are in the way.

Thank you for choosing us!

A pest-free environment in your home or business is our goal. In order to help us better serve you, this brochure contains an outline of what to expect from our services.

Our general preventive spraying includes all normal occurring insects found in the great State of Montana. This type of spraying may include an elimination of certain types of insects like ants or yellow jacket nests. If you notice a wasp or hornet nest on your structure, call back appointments between visits will be \$75.

What if You See More Bugs?

You may see more bugs after we have been there. This is normal and is an indication that our service is working. This is due to the flushing agents in our products. Please note spiders can take up to 2 hours to die, once they have a fatal dose.

Mosquito Control

The Flathead County Mosquito Control program has trained technicians that will work with you to reduce mosquitos.

What to Know:

At this first visit we gave the technician enough time to meet with you, inspect the structure, and perform the service. We require payment for the treatment, either by check or by credit card with the technician. We can also put a credit card on file if you prefer.

The technician will discuss the cost of follow-ups with you at the first service.

Our invoices are sent by email, you have the option to pay online from the invoice, or remit a check.

Our system is also designed to send electronic appointment reminders several times before each service. Let us know if you have a day or time preference.

Specialized Treatments?

Bed bugs, gnats, roaches, and fleas require more focused and intensive treatment, the cost for these services is higher. If you believe you have any of these pests in your home, please contact our office for more information.

Treatment Recommendations:

In general we highly recommend a minimum of 3 treatments per year, 1 in the spring, 1 in the summer, and one in the fall.

Every time we are out on a regular service call, the technician will also look for and treat any wasp/hornet nests that are visible, as a part of the service. We guarantee elimination of nests only.

If your initial treatment for was for ants, we highly recommend two follow-up appointments; one in 45 days, and then and another 45 days after that.

Crawl spaces are treated at the initial service. On follow-up appointments, at the discretion of the technician, a fee of \$35 or more may apply.

Rodent Problems?

If your property was treated for rodents at your initial appointment, these services will be included in your service plan. If a rodent problem has developed on your property, please speak with your technician or call our office to have these services added to your treatment plan.
